- 1. The Mississippi legislation would significantly expand the state's DNA database to include all persons in state prison.

#### STATE LEGISLATION

### **Forensic DNA**

- 1. Georgia HB 1530 -- Study bill for post-conviction DNA testing.
- 2. Idaho HB 660 -- Transfers authority for DNA collection to State Police from Department of Law Enforcement (mostly a "housekeeping" bill).
- 3. Minnesota HB 3345 -- Allows complaints to be filed against unnamed defendants, provided there is sufficient DNA evidence.
- 4. Mississippi HB 1425 -- Expands DNA analysis requirements to include all persons in the custody of the state's Department of Corrections.

### **Genetic Privacy**

- 5. Rhode Island HB 7905 -- Genetic information is the property of the individual. Requires notification when storage location of a sample is changed.
- 6. Rhode Island HB 2599 -- Prohibits insurance companies from using genetic testing in any aspect of coverage.

- 1. Discussion of death penalty. Criticizes Florida for denying inmates access to DNA technology.
