COMMENTS

1. DNA expansion bills in Connecticut (articles 2 & 9), Florida (articles 16 & 27), Georgia (articles 14 & 25) and Kentucky (article 19) received legislative and media attention this week.

STATE LEGISLATION

Forensic DNA

- 1. Michigan SB 594 (Enacted) Expands DNA databases to include murder, 1st-4th degree criminal sexual conduct, assault with criminal sexual intent, and kidnapping.
- 2. Pennsylvania SB 1 Appropriates \$303,000 for DNA Lab improvement.
- 3. Utah SB 1 Appropriates \$1.636 million for state crime labs.
- 4. Washington SB 6404 Appropriates \$50,000 on the condition that HB 2491 (post-conviction testing) is enacted.

Genetic Privacy

Idaho SB 1567 – Prohibits genetic discrimination in insurance and employment.

- 4. Georgia Senate agrees with House that a man cleared of a rape conviction by DNA evidence is due reparations.
- 5. DNA taken from children of missing woman in an effort to identify a body.
- 6. Convicted Massachusetts rapist says DNA tests exonerate him.
- 7. Tennessee House passes a bill that allows for post conviction DNA testing.
- 8. New York DNA database gets first "cold" hit from a sample given by a robbery convict. Hit links convict to a murder committed 20 years ago.
- 9. Connecticut Judiciary Committee is considering all arrestees bill key legislator voices concern of sample being used against people for health insurance matters.

- 21. "Public defenders are not immune form malpractice suits" Defender who did not test DNA evidence is sued for malpractice.
- 22. Virginia bill to extend "21 day rule" is dropped for this year sponsor hopes to get more than the Senate-approved 45 day extension next year. Legislation seen as needed in light of new DNA technology.
- 23. Man in Oklahoma fighting extradition of his DNA sample to New Mexico for comparison against murder evidence.
- 24. Indiana Governor seeks death penalty review. Review is not expected to be ready in time for the 2001 legislature.
- 25. Both the House and Senate in Georgia have approved legislation requiring DNA samples from all convicted felons.
- 26. US Supreme Court refuses to lift the stay of execution granted to man who believes DNA evidence will overturn his conviction.
- 27. Democratic legislators in Florida form coalition to fight "liberal" label. Agenda approved by the group includes bill requiring DNA samples from burglars.

Genetic Privacy

- 28. Iceland licenses US company to study the medical records (including genetic information) of its citizens.
- 29. Washington legislature may not act on privacy bills (which includes privacy of DNA information). State senator is attempting to have the bill included as an initiative on the November ballot.
