#### **COMMENTS**

- 1. The Georgia bill to require DNA samples from all felons continues to move through the legislative process and has received friendly treatment by the press (article 16). Articles 9, 10 and 24 discuss New York Governor Pataki's proposal to gather samples for Class B misdemeanors and greater.
- 2. FBI Director Louis Freeh has asked Congress for funding for a federal offender DNA database and authorizing legislation.
- 3. Several newspapers around the country carried articles regarding the problem of DNA backlogs a sampling of these articles can be seen in #'s 1, 5, 7 and 8.
- 4. Newspapers were also very interested in cases of warrants or indictments issued for unknown rapists identified by DNA, and in discussions of extending the statutes of limitations (see articles 2, 6, 11, 23 and 13, 14 and 21 respectively.

### STATE LEGISLATION

## **Forensic DNA**

- 1. Florida SB 2202 Appropriations guidelines bill expects 24,000 DNA samples to be added to DNA database.
- 2. Minnesota HB 2688 Eliminates statute of limitation for any crime resulting in death and kidnapping crimes. Allows indictments any time for  $1^{st} 3^{rd}$  degree criminal sexual conduct, provided the crime was reported within 72 hours of commission.
- 3. Minnesota SB 2974 -- Eliminates statute of limitation for any homicide and for kidnappings. Allows indictments any time for  $1^{st} 3^{rd}$  degree criminal sexual conduct, provided the crime was reported within 72 hours of commission and there is DNA evidence.
- 4. Mississippi SB 3279 Sets forward appropriations performance measures for DNA analysis.
- 5. Pennsylvania HB 2361 provides federal funds for "DNA Laboratory Improvement" at \$303,000.
